Federal and State laws, and University policies, protect students, faculty and staff from discrimination based on the following legally protected characteristics: Race, Color, Creed, Religion, National Origin, Sex (including pregnancy and parenting status), Age, Veteran Status, Disability, Marital Status, Sexual Orientation, Gender Identity and Expression, and Genetic Information (see www.wvu.edu/eoo and Western's Policies on Ensuring Equal Opportunity & Prohibiting Discrimination & Retaliation and Preventing & Responding to Sex Discrimination, Including Sexual Misconduct).

In compliance with Title IX of the Education Amendments of 1972, Western does not discriminate on the basis of sex in its educational programs and activities or in employment.
