POL-U1400.02 ESTABLISHING TUITION RATES AND REGISTRATION FEE FOR SUMMER SESSION; IDENTIFYING OTHER FEES CHARGED DURING SUMMER SESSION

This policy applies when establishing tuition rates and registration fee for summer session and in charging other student fees applicable to summer session.

1. Summer Session Tuition Rates shall be based on the Preceding Academic Year's Part-time Tuition Rates (tuition operating fee and capital building fee) and will be charged on a Per Credit Basis.

- A. For **undergraduate courses**, summer session per credit hour fees will be equal to or less than the per credit hour fees for part-time undergraduate residents during the previous academic year.
- B. For **graduate courses**, summer session per credit fees will be equal to or less than the per credit hour fees for part-time graduate residents during the previous academic year.
- C. For **non-resident students**, summer session per credit hour fees may be at a higher per credit hour rate than for resident students.

2. University maintains a defined process for proposing and establishing Tuition Rates and Registration Fee for Summer Session -- see Procedure PRO-U1400.02A.**3. Summer Session Students shall be charged Applicable Fees**

- A. All summer session students pay a Services and Activities Fee.
 - I. The Services and Activities fee for summer session is approved by the Board of Trustees in June, a full year in advance of the summer session.
 - II. The Services and Activities Fee for summer session is established and charged on a per credit hour basis at a rate that reflects summer program levels of service and activities.

- III. The Services and Activities Fee for summer session is not subject to the 3.5% loan service fee as summer students do not participate in this loan/grant program.
- B. Other Mandatory Student Fees: All summer session students are charged mandatory students fees as established for the academic year proceeding summer session.
- I. For students enrolled in 6+ credit hours, mandatory fees include:
- Health Service Fee
 - Technology Fee
 - Non-Academic Building Fee
 - Student Recreation Fee
- II. In addition to the above fees, effective Summer 2006, summer session students will be charged the Renewable Energy Fee, to be levied on a per credit hour basis from 1 credit hour to a maximum of 10 credit hours per quarter.
- C. Registration Fee: All Summer Session students will be charged a summer session registration fee, as approved by the Board.
- D. Course and Lab Fees: All summer session students will be charged applicable Course and Lab Fees, as appropriate, based on course and lab fee levels, fixed or variable, as established for the academic year proceeding summer session.
